One of the most joyful accomplishments we get to celebrate at CHSA is the sale of homes to buyers with modest incomes. June is <u>National Homeownership Month</u> - and CHSA invites you to support potential

home owners. Memorial Healthcare is only one of the employer assisted down payment programs administered by CHSA through the Savannah Affordable Housing Fund. Businesses located outside of the City of Savannah are also eligible to establish down payment assistance through the CHSA Fund.



Home Ownership Rates in Savannah are Low


Fewer people own the homes they live in, especially persons of color. Home ownership can be more affordable than renting, yet only 44% of Savannah residents own the home they live in. CHSA provides technical support and financing opportunities that support home ownership for households with modest wages.
