CHSA Receives Neighborhood Champion grant from Bank of America for Capacity Building

CHSA is the 2023 Bank of America Neighborhood Champion® awardee for our work advancing economic mobility and building up underserved neighborhoods in Chatham County. CHSA's programs address economic mobility by increasing access to affordable housing. This multi-year grant funding and leadership training will allow CHSA to increase capacity and develop a long-term strategy to create even more affordable housing.

"CHSA has served hundreds of persons in the past, but there are thousands of Chatham County residents in need of affordable housing," says Anita Smith-Dixon,

CHSA Executive Director. "The Neighborhood Champion funding and training will help CHSA increase its organizational capacity and ensure that we grow in a sustainable manner."

Through the program, CHSA staff will participate in virtual leadership training delivered by experts in the nonprofit sector on topics like human capital management, increasing financial sustainability and storytelling. CHSA also will receive a \$50,000 grant over two years. The invitation-only program is highly competitive, and nonprofits are selected by a committee comprised of community leaders and past awardees.





One house I visited when I worked for the City gave my heart pause. Generally, the Home Repair program is focused on exterior repairs. The house I visited I knew would not qualify for the program because most of the repairs needed were inside. But the resident needed help and had few resources or family to support her.

I got in my car, and just talked to Jesus. It was 100 degrees outside that day, but I just had to sit and pray for a solution. Finally, I started to drive away. But I stopped when I saw a group of guys sitting in a lot down the street, in the shade. I stopped to talk, and sure enough, they knew that neighbor. And, they asked to go see what she needed. This is Why I Give to CHSA: An Interview with Board Member Fred Madsen

My introduction to CHSA was a tour with Anita Smith-Dixon, back in 2018. I was a new retiree and looking for some ways I could give back to the community. The Savannah Gardens project was in process, and the transformation of Cumming Street was just an idea. But what struck me was the passion Anita had for the possibilities! I was hooked.

Like many retired executives, I was familiar with the challenges of homelessness and the lack of affordable housing in other cities. But in Savannah, we are making serious investments to give a "hand up," not just a "handout," to people. CHSA is pro-active. We take abandoned properties and get them back on the tax rolls. CHSA creates value by building solid, quality homes people can afford to buy. Even with the challenges of inflation and limited capital, CHSA invests in housing for real people who need opportunities to purchase real assets.

I give to CHSA because affordable housing affects the whole community. Affordable housing attracts workers to jobs here, builds up our tax base to support our schools, and builds our reputation as a great place to visit for tourists. We don't make subsidized housing; we create homes for people willing to "carry their own water."
