## From Tangled Title to Legal Heirs Honoring Granddaddy and Family Gatherings

Dekisha, Kimberly, LaVondra, and Romon Hamilton have happy memories of growing up in East Savannah. Their mother, Gloria Jean Hamilton, inherited her parents' home and raised her children there, in addition to caring for extended family. As the older generation aged, however, caring for the house became more difficult.

In her final years, Ms. Hamilton moved into an assisted living facility. One of her brothers still lived in the home, but was unable to keep up with the maintenance. After she died in 2019, she did not leave a will for her heirs. The siblings owned the house together as "tenants-in-common." They had what is known as a "tangled title," an heirs' property.

After their uncle also moved into assisted living, the Hamiltons struggled to keep up with maintenance and taxes. "We are not homeowners and we didn't know the different resources that could help with this process," says Dekisha. Fortunately for them, their uncle Ron Hamilton did know of some resources —at CHSA.

CHSA just established the Heirs' Property Tangled Title Legal Fund to help heirs like the Hamilton family to access the legal funds required to resolve a "tangled title."

"Our new Heirs' Property Tangled Title Legal Fund is a revolving fund that families can use to work through the legal process. We also provide technical assistance and access to financing for renovations. Our goal is to help families bring their properties back to the best and highest use," says Anita Smith-Dixon, Executive Director of CHSA.

The family is working with attorney C. Elisia Frazier. "The first step to untangling an heirs' property title is to understand the family structure. Many heirs find the genealogy research is an unintended benefit. Once we understand the family structure, the legal part is my responsibility," says Ms. Frazier.

Now that their future points toward home ownership, they are dreaming about property upgrades instead of worrying over legal issues. "We probably will modernize the house," says Dekisha as her siblings nod. "And maybe add another bathroom. Grandaddy had a storage shed in the back when we were little, so we've even talked about a backyard tiny house for when relatives visit."

Anita Smith-Dixon adds, "By helping heirs restore their family properties, CHSA is keeping housing affordable in Savannah, particularly for those who may no longer be able to afford to buy."

Dekisha is looking forward to inviting her aunts and uncles to a crab boil soon. "It was granddaddy's home. The crab boils and the togetherness and family love... the summers we spent together there were so rich for us in our past," she says.



Over \$1.7B in Heirs Property are Located in Chatham County



The Georgia Heirs Property Law Center worked with NASA DEVELOP to estimate probable heirs properties in Georgia. The study used property appraisal data and geospatial mapping tools to identify probable heirs properties in the path of 2017's Hurricane Irma. The study found that the estimated tax appraised value of heirs property in Chatham County was \$1,731,113,515.

The Georgia Heirs Property Law Center estimates that there is \$47 billion in "frozen equity"-- property assets with tangled titles-- statewide!
